

Business

- A massage therapist "also" has to be a/an
 - Business person
 - Owner
 - Bookkeeper
 - Manager
 - Advertiser

Success

- Is based on
 - -Self-esteem
 - Positive attitude
 - Enthusiasm
 - Reputation
 - Professionalism

Business Ethics

- Practice professional code of ethics
- Standards of acceptable and professional behavior to conduct good business

Business Ethics

- Setting up fees
 - Based on
 - Where practitioner lives (city, state)
 - Whether practitioner works alone
 - Whether partners are involved
 - Whether practitioner works for someone else
- Bookkeeping: keep accurate records

Planning the Business

- State mission
 - Focus of interest of the business "public image"
- Purpose
 - "Theme" of your idea

Planning the Business

- Goals
 - What practitioner wants to accomplish
 - Support your mission and purpose
 - 1 year, 5 years, long term
 - Be realistic, specific, attainable
 - Example: Full/PT business, number of clients each week, time schedule, setup, fees, profit

Beginning a Business

- To decide to work for someone else, oneself, or both
- Oneself—in own home, rent or buy facility
- Someone else—spa, salon, doctor, hotel, hospital, ship, gym, etc.

Types of Business Operations

- Sole proprietor
 - Individual owner, own expenses, liabilities and assets—all business obligations are practitioner's own including tax responsibilities
- Partnership
 - Investment and profit shared—need clear agreement

Types of Business Operations

- Corporation
 - Must be obtained from state—name, board of directors, stockholders
 - Not liable
- Limited Liability Company (LLC) between corporation and partnership
- All need insurance

To Start Up

- Rent/lease—plus security
- Utilities—(hookup, deposits) gas, electric, phone
- Equipment/supplies—table, linens, bolsters, oil
- Furniture—desk, chair, file, lighting, music
- Decorating—paint, drapes, plants

To Start Up

- Office supplies—computer, copier, pens, etc.
- Advertising—cards, brochure, printing, ads, stationery
- Insurance
- Bank account—separate, checks
- Business location—home office, rent/lease, purchase

To Start Up

- License and permits
- Name—filing at county clerk's office
- Business permits—town zoning, restrictions
- Massage license—usually state, if needed

To Start Up

- Employer ID (EIN), federal tax ID#
 - Contact IRS—needed if partnership or have employees
- Safety permit—comply with town and fire
- Planning/zoning permit—town board

Protecting the Business

- Malpractice insurance
 - AMTA, ABMP, *Massage* magazine
- Liability insurance
 - Homeowner's or from landlord;
 otherwise, must get
- Fire and theft
 - Landlord may cover; good idea to get own

Physical Layout/Floor Plan

- Plan for convenience, comfort, economy, and efficiency of operation
 - Need access
 - Reception area
 - Consultation area
 - Restroom
 - Proper lighting
 - Proper furniture and equipment

Marketing

- Promotional, discounts
- Referrals
- Business card: include name, title, phone, email, modalities, appropriate design and appointment only, Web address
- Advertising, doctors' offices, post office, holistic news
- Public relations

Massage Therapy Advertising Should Convey a Professional Image

Self-Employed or Independent Contractor

- Own work schedule, fees, supplies, taxes.
- Rent space and operate business within another business (salon, gym, nutrition)

Self-Employed or Independent Contractor

- Work in home: great financial benefits;
 e.g.- no rent
 - Tax benefits—home office, business expense
 - Check with town zoning laws
- Work in private office—alone; own reception
 - Co-op office—with other MTs

Self-Employed or Independent Contractor

- Out calls only
- Work in space of large business—e.g. salon, spa, chiropractor, gym (need contract/terms of agreement)
 - Advantage—reception, partial rent, own hours

Taxes

- W-2—by employee
- 1099—independent contractor
- Schedule K-1 (partner)
- 1040—individual

Taxes

- 1040-ES—self employed
- Schedule C—sole
- Schedule SE
- Year-end wage and tax statement; submit with 1040

Taxes

- Year-end wage and tax statement more than \$600 income
- Year-end wage and tax statement = to W-2
- Year-end tax form
- Estimated quarterly tax
- Business profit and loss for year
- Self-employment tax form attached to 1040
